The PPP model has pros and cons, particularly where these jurisdictions tend to deal with uncodified or other clear legal PPP frameworks in place. This session will explore trends and themes in the approach to such projects while exploring whether PPP remains a suitable model, even in whatever form it takes on the ground.
